Minutes

1. Welcome

Chairman Djurkovic and EHF Chief Sports Officer Glaser welcomed the CC members and gave a brief overview about the upcoming meeting. Djurkovic informed that two additional topics have been added to the agenda. One has been proposed by Pelletier concerning club competitions, and a second one by Glaser addressing women's competitions in general. Both of them have been inserted under agenda 4.3.

Since the EHF Finance Delegation meeting was taking place at the same time, Secretary General Hausleitner planned to visit all three commissions separately throughout the afternoon.

2. Minutes and Reports of Meetings and Task Groups

No remarks were made.

3. Information on Meeting of Technical Delegation / CAN

Djurkovic summarized the most important topics which had been discussed one day prior. The TD notes will be made available to all CC members for reference.

4. Club Competitions

4.1. Review Men's and Women's Club Competitions 2023/2024

The season ended successfully and without any issues or complications. No decisions or particular measures are necessary.

4.2. Preview Men's and Women's Club Competitions 2024/2025

248 registrations in total have been received for the new season, Scheder reported. Compared to the previous season the following numbers resulted:

The No.4 seeded team, Neptunes de Nantes Handball (FRA) withdrew from the Competition.

As the next-best ranked Nation in the 2024/25 EHF European League Women Ranking without a fixed place in the Group Phase, the best seeded team from HUN (Motherson Mosonmagyarovari KC) was awarded with this place.

There will be no replacement for Motherson Mosonmagyarovari KC in Qualification Round 3.

Therefore their opponent, the Winner of Qualification Round 2 Match 5 (Fredrikstad Ballklubb (NOR) vs. GC Amicitia Zürich (SUI)) will directly advance to the Group Phase

The club competition season will start on 31 August with the first leg of Men's European League Qualification matches.



As a reminder Scheder explained the approved procedure regarding the special qualification way to the Men's European league Group Phase for the teams from the lower ranked Federations. A total of three teams registered this time for this special qualification. As this was an odd number HC Vojvodina (SRB) as the best ranked team among the three qualified directly to the Group Matches while the other two teams, RK Izvidac (BIH) and HCB Karvina (CZE), will play the qualification.

4.3. Input from Club Representatives and further topics

Pelletier explained that it is in general complicated and causes troubles with the airlines if teams travel with a bigger number of balls on an airplane to away games. They need to be packed in an oversized baggage, must be deflated and a lot of times do not arrive on time at its destination he mentioned. It is therefore proposed from the side of the clubs, supported by the FCH, that the home teams should provide 16-20 balls for the away teams and no balls would have to be brought along to an away game anymore.

The CC members were in favour of this request. Glaser pointed out that this change will result in a change of the regulations and therefore cannot be implemented immediately. He also noted that it must be made mandatory for all men's and women's club competitions (or at least those with a group phase), as Pelletier recommended. Several issues of this proposal will be clarified before the topic can be decided and a motion to the EXEC will be tabled.

Mitrunen noted that it also causes issues at National Team Competitions to bring along a physio bed to an away game. It was advised that agreements shall be made among the competing teams ahead of the travel, that the home team must provide a physio bed for the away team.

At this point of the meeting Glaser summarized the issues regarding EHF Women's competitions in general.

There was very low interest by the Federations to host a W17 EURO or W19 EURO in 2025 despite a raise of the daily rate to 170€ per person per day.

Furthermore, it is currently very difficult to find a hosting federation for the tournaments of the 2025 WWCh Europe Qualification Phase 1 even though the tournaments only include three teams and it was particularly wished by the federations concerned to play a tournament instead of home and away.

He reminded on the 2024 Women's Euro Qualifiers where there was no phase 1 and various matches in phase 2 produced very one-sided results with several federations indicating that they will not register anymore for the 2026 Qualifiers except if they can play phase 1.

The Women's Champions League hardly manages to have 16 competitive teams and several attempts with new clubs in the last two seasons failed. The consequence was to include three teams from some federations, which reduced the overall number of countries resp. markets. Serious economic difficulties were reported at the beginning of the summer around Buducnost from Podgorica (Women's Champions League / MNE) which became only better after obviously the city of Podgorica will act as an economic security umbrella for the club.

Neptunes de Nantes (Women's European League / FRA) withdrew from the competition in August due to losing their sole club investor.



Vipers Kristiansand (Women's Champions League / NOR) appeared in the media in mid-August with a report about serious economic difficulties in the club and quite a large amount of money was mentioned that is needed to further operate normal business.

Glaser explained that it is a first step to have an overall information about the different situations in order to understand that the difficulties are evident across all women's competitions.

The CC discussed these inputs and agreed that there is a need to pay special attention to this issue and to further look into it.

5. Refereeing topics

5.1. Status of referee pairs in EHF for the 2024/25 season

128 referee pairs (106 male and 22 female) have been registered with the EHF for the new season. 15 male, 9 female and 1 mixed pair are currently in the pool of Candidates, whereas 25 male and 18 female pairs are within the Young Referee Programme (YRP).

The CC was informed that EHF referee Ruslan **Loshak** from UKR moved to LTU and is working there as a teacher. Due to the war in UKR him and his Ukrainian referee partner Anatoliy **Novikov** experienced several issues officiating together abroad, therefore he started refereeing in the Lithuanian league with Mindaugas **Gatelis**. As both have the EHF badge, the EHF was contacted by LTU and UKR asking if they can officiate together as an EHF referee pair. An observation by an EHF Referee expert will be done in LTU and, in case of a positive feedback, the pair will be confirmed as EHF Referees.

Nine referee pairs ended their careers after the previous season/the Olympics.

5.2. Review EHF Candidate Referee courses in 2024

During the past months two EHF Candidate Referee courses took place. Six pairs from SRB, SWE, ISL, FRA, NOR and ROU passed the course in April in Drammen, NOR, successfully. The second course was organized in Pristina, KOS, on the fringes of the M20 Championships in July. A total of



eight pairs participated, of whom seven passed the course (GER, DEN, CRO, MNE, CZE, SUI and KOS). The referee pair from UKR did not pass the course (one of the referees failed the conditioning test, while the pair was clearly lacking consistency and cohesion during the matches due to the fact that its members live apart from one another, in different countries because of the war in UKR). It needs to be understood by the National Federations (NFs) that they must only send a referee pair to an EHF referee course if the referees are familiar with the Rules of the Game, speak English sufficiently and are well trained for the course, Mitrunen explained. Most of the courses are taking place on an annual basis, which allows NFs to fully prepare their referees and only send them once they are ready. The goal should be, being able to pass the course.

Each NF received a detailed report about their referees after both courses.

Bebetsos pointed out that due to the large number of parallel IHF events (including IHF candidate courses) running during the summer, several referee pairs were unavailable for EHF YAC events. In addition, three referee pairs withdrew their nomination on short-term for the M20 EURO in SLO due to injury. It was therefore challenging to appoint referee pairs for the EHF YAC competitions and some referee pairs, who had just passed the EHF candidates course in Drammen, were already nominated for YAC events, as there were not enough existing EHF pairs available during the summer.

5.3. YRP status and activities in 2024

A total of six courses took place during the past months:

- HUN Veszprem, Balaton Cup (5 pairs: ESP, HUN, FRA, ROU, FAR)
- BIH Brcko, Lokomotiva Cup (7 pairs: GER, GRE, HUN, MKD, SRB, SVK, SWE)
- CZE Prague, Prague Cup (6 pairs: ITA, CZE, BIH, TUR, CRO, FRA)
- SWE Gothenburg, European Open (11 pairs: NED, DEN, SWE, MNE, CRO, ROU, ITA, AZE, POR, IRL, NOR)
- HUN Debrecen, EUSA Games (10 pairs: BIH, CRO, ESP, GER, HUN, KOS, MNE, SLO, SWE, UKR)
- GER Sparkasse Cup Berlin was taking place parallel to the CC at the end of August with a total of 4 invited YR pairs (FRA, GER, LTU, SRB)

As for the next season 2024/25, EHF has started receiving invitations to stage YRP courses at various events (i.e. in Porec, CRO). All invitations will be evaluated by the EHF office.

5.4. New age limit for ending the international referee career

Earlier this year the IHF lifted the age limit for IHF referees from 50 to 55 years. The EHF follows this new approach, however, deals with it on a case-by-case basis by considering the individual situation of active referee pairs in a federation where the situation occurs. In general, the idea is to make sure that older pairs are not in the way of the development of younger pairs, especially of those who have potential.

Not all of the previously mentioned referee pairs (see 5.1.) who ended their career, reached the age limit, Bestilleiro reported. It is common that every four years after the Olympics, experienced



referee pairs end their career even though they have not reached the age limit yet, but their priorities in life have changed.

5.5. General review YAC competitions 2024

49 delegates and 77 referee pairs participated during the YAC summer tournaments:

- SWE Gothenburg, W16 EHF European Open 2024 (9 delegates + 11 referee pairs)
- SLO Celje, M20 EHF EURO 2024 (12 delegates + 14 referee pairs)
- KOS Pristina, M20 EHF Championship 2024 (5 delegates + 8 referee pairs)
- MNE Podgorica, M18 EHF EURO 2024 (12 delegates + 14 referee pairs)
- SVK Hummene, M18 EHF Championship 2024 (5 delegates + 5 referee pairs)
- KOS Pristina, M18 EHF Championship 2024 (4 delegates + 5 referee pairs)

As mentioned earlier, three referee pairs had to be replaced before the start of the M20 EHF EURO in SLO due to an injury. Bestilleiro explained that it was expected being difficult having enough referee pairs and delegates available for the summer tournaments. This was due to the increased number of teams during the EHF YAC competitions and the increased number of teams at IHF events.

All 77 referee pairs were tested in conditioning prior to the start of the event, and only five failed the test. In addition to this, all the nominated referees and delegates submitted rule, regulation, and English knowledge digital (online) tests with satisfactory results.

No major referee issues have been reported, though several delegates and office staff caught a virus during the M18 EHF EURO in MNE. One delegate was hospitalized for about two weeks and had to undergo surgery in MNE. The organising committee was very supportive and helpful during this period, Bebetsos emphasized.

5.6. Women's EHF EURO 2024 – Preparatory activities

At the beginning of July, the EHF Officials who were nominated for the Women's EHF EURO 2024 had been announced publicly. In the meantime, it turned out that the referee pair from TUR, Pinar **Unlu Hatipoglu** / Mehtap **Simsek**, must be replaced as one of them got injured at the start of the summer and she will not recover on time. All remaining referees will undergo a fitness test during the Officials' Preparatory Seminar for the EURO, which will be taking place in Vienna from 27 to 29 September.

The EHF will follow the IHF Officiating line for this event, which is the same as implemented during the 2024 Olympics. Bebetsos further pointed out that all nominated referees and delegates will be briefed on this during the preparatory seminar for the EURO in Vienna at the end of September. All active TRC members will attend the seminar, too. Among others the following topics shall be covered during the seminar:

Togstad / Ehrmann-Wolf (TRC): Officiating line Reibel / Sondors (TRC): Delegate preparation

Jaworski, Jakub / Babaroutsi, Irini: FitGood Pro – conditioning, nutrition



Boss, Jürgen: Mental coaching Capela, Joao: Video Replay Manager

Birkelund, Daniel: Coaching

Glaser underlined the aim for the event which is to strengthen the knowledge of the participating EHF Officials and to build a strong officiating team for the event. Especially as several of the participating referee pairs have less experience at major handball tournaments compared to their counterparts at the Men's EURO, the seminar is considered necessary and beneficial. Compared to previous years the seminar has been moved from end of August to end of September to minimize the gap between the course and the start of the EURO.

Togstad and Bebetsos will introduce the officiating line and the use of officiating technology at the EURO coaches' webinar (online).

5.7. Activities in referee education

Regular online courses were organized in the last season and will continue. Educational clips will be produced as a preparation for the Women's EURO.

It is currently under elaboration if courses shall also be organized for Champions League coaches ahead of the season. In addition to this it is being discussed, if a VR Responsible in each federation would be beneficial especially for the knowledge transport to the federations. Bebetsos explained that a National VR Manager course would be staged on a strict attendance/practice/examination basis, using VOGO systems as well, and the respective licence will have a certain period of validity. The issue will be discussed further to see if it is feasible and beneficial or not.

As the EHF is continuously striving to improve its educational programs a consequence is to regularly update the list of experts.

5.8. Officiating technology – Preview 2024/25 season

The TV Referee Observer (TRO) turned out to be a very useful and successful position during selected matches of the knock-out stage of last season's men's and women's Champions League. Within 48 hours an online meeting took place among the referees and the TV referee observer, where the TRO evaluation was offered also using video clips from XPS Sideline. It is still the task of the delegate in the hall to observe the atmosphere around the referees in the hall.

VOGO VR systems are installed in the home arenas of the new clubs of the Champions League. Online education for the referees and delegates of the Champions League matches is planned in an effort to better implement and coordinate the use of the system at the EHF Champions League matches. Further, VOGO and the EHF Officiating Unit created an online application imitating the use of the system allowing the referees to practice at home on the proper and compact use during the matches.

The EHF Officiating Unit is planning the creation of a VR animation video that will be played on the cube in each arena, before the match, to explain spectators on the situations where the use of VR



is possible. A search for a production company and estimation of the production cost is undergoing. Once created, the video is ready to be played at the EHF EURO and Champions League arenas.

5.9. **Conditioning program**

The EHF is continuing its cooperation with FitGood Pro, the same service provider as for the IHF. FitGood Pro is continuously supervising a pool of EHF referees, but the results are also dependent on the feedback from the NFs concerning the shuttle run test. It is planned to integrate a new fitness test in the closer future, but potential cooperations with two German universities were not successful. Instead, Prof. Marco Cardinale from Aspetar (EHF Expert also) had been contacted for further recommendations. His proposal was instead of inventing an entire new test, to look into the FIFA Futsal Referee test, as those referee conditioning requirements are similar to the ones of handball. An alignment with the IHF is also a topic as it is considered as useful if both organizations use the same procedures.

As the fitness program is run in cooperation with the IHF and FitGood Pro, the costs for the Polar watches are split among the IHF and EHF. Several monitoring devices (Polar watches) will be obtained by the EHF and distributed to newcoming referees in the conditioning program.

5.10. Integrity education program

The 2-year Integrity program with Sportradar has been concluded. A total of 287 referees, 220 indoor and 67 beach referees have been certified.

Potentially the EHF will collaborate in the future again with Sportradar, in a program aiming to create "National Integrity Ambassadors" (train-the-trainer type) but nothing has been decided vet, Bebtsos informed.

5.11. Media activities in Officiating

"The Final Whistle 3.0" has been a very successful campaign and shall continue throughout the Women's EURO 2024. Each video exceeds 1,000,000 clicks within 12 hours from the moment posted in EHF's social media channels. The social media audience is obviously very much interested in attending referee communication and interaction (mic'd up) during the matches.

5.12. Referee nominations for friendly matches

An increased tendency of referee pair nominations for international friendly matches is still being noticed. The respective numbers are indicative:

2021: 15 nominations 2022: 22 nominations

2023: 32 nominations

2024 (up to now): 34 nominations

The National Federations must be encouraged to request a nomination for their international friendlies by EHF, as this increases the integrity factor and image of their games on the one hand and providing considerable training base for the EHF referees on the other hand.



5.13. IHF matters

At the end of June, the IHF distributed the updated Rules of the Game, which have been implemented in EHF competitions from 01 July 2024. Bestilleiro highlighted that the cooperation with the IHF PRC is good and that after the IHF summer events he received respective reports about the referees from Europe.

5.14. Miscellaneous

Bebetsos informed that it is under discussion to print the last name of the referees who are refereeing at EHF EUROs in small letters on the referee's jersey. This is to show more recognition to the referees and to make them more visible on TV. He further added that this "policy" was already used by FIFA and UEFA in their last competitions (World Cup and EURO), while in Basketball every referee has a personal number instead and in Volleyball neither nor.

6. Delegates Matters

6.1. Status of delegates for the 2024/25 season

141 delegates (114 male and 27 female) are active for the new season. 7 experienced delegates retired after the last season due to the age limit. Sadly, an active EHF-Delegate, Shqipe Bajcinca-Brestovci (KOS), passed away after an illness in spring 2024.

6.2. General review YAC Competitions 2024

A precise report about the YAC events will follow in due course.

6.3. Activities and tools in delegate education

It is in the planning to organize an online course for delegates who regularly attend Champions League matches on topics related with the use of VR.

Furthermore, a new approach about the referee performance evaluation has been initiated. The EHF Officiating Unit produced and distributed the new EHF Referee Performance Evaluation Manual, a detailed and compact tool for a more precise and concrete evaluation of the referees. The "Use of VR" is the new item-to-be-evaluated in the Referee Performance Evaluation (RPE) form.

6.4. Status e-learning and testing

E-learning and testing activities are regularly carried out with the aim to make the Delegates better understand where they have weaknesses. This is then followed-up so that the overall level can be improved.

6.5. Preview Candidate Delegates' Course 2025

Glaser informed that another Candidate Delegates' course is planned for spring 2025, which is two years after the previous course. Details need to be clarified and the budget for this activity needs to be approved.



7. National Team Competitions – Qualifications

7.1. Review past competitions

Women's EHF EURO 2024 Qualifiers (Phase 2)

The qualification group rounds have been played accordingly:

- rounds 1 and 2: 11 15 October 2023
- rounds 3 and 4: 28 February 3 March 2024
- rounds 5 and 6: 3 -7 April 2024

24 teams qualified for the Women's EHF EURO 2024, Heim reported. Directly qualified were 4 teams: NOR (defending champion), AUT, HUN and SUI as organisers. The remaining 20 teams are:

7.4. 2026 Women's EHF EURO and EURO Cup

Due to the fact that out of the 24 available places at the final tournament eight are participating in the EHF EURO Cup, 16 places remain for the teams playing in the Qualifiers. The Qualifiers will be played in two phases. In the first phase the lowest ranked teams of the respective ranking list will be competing for place(s) – maximum two based on the total number of teams registering for the Qualifiers. In phase two the pre-qualified teams based on the respective ranking list together with the team(s) from phase one will be competing for the 16 available places in the final tournament.

Phase 1 will be played preferably in a tournament format (round robin system), if this is feasible due to the number of registered teams. Alternatively, those matches may be played as Play-off matches. Phase 2 will be organised with 24 participating teams in six groups of four teams, each playing in a round robin format in six rounds. 12 teams will qualify, and the teams ranked first and second in each group of the Qualifiers after completion of all matches will qualify for the final tournament. To determine the remaining places (4) different options are currently under evaluation. This includes the comparison of the third ranked teams across all groups as it was in use for the last EUROs. Alternatively, a system is evaluated by defining the third ranked teams via matches.

The Qualifiers Draw is foreseen to take place on 20 March 2025 with the venue still to be decided.



Due to the fact that the EHF EURO 2026 will be hosted by 5 nations the playing format for the EHF EURO Cup needs to be adapted. Until now, the EHF EURO Cup was played with 4 teams only. Due to the five organising countries a playing system with altogether 8 teams where the 3 best ranked teams qualify out of the results of the EHF EURO 2024 will be implemented based on the EXEC decision in April 2024. The respective EXEC decision reads as follows: Besides the winner of the Women's EHF EURO 2024 and the 5 hosts, the 2nd and 3rd best ranked teams (excluding the hosts) at the Women's EHF EURO 2024 will play the EURO Cup. She further expressed her concerns about the fact that the person from the OC who was in charge of indoor handball was also in charge of beach handball, which caused a big workload, and it was difficult for her to manage both events simultaneously.

As the quality of the matches was very high, it was tough matches for the referees, Bestilleiro added. At the EUSA Games there is no delegate foreseen at the table, therefore no direct person can support the referees during the matches, which should be changed in the future.

Müller reported that the throw-off times for the final tournament have been confirmed and the match schedule is attached hereto. The arrival venue for the EHF Officials has been set for Vienna for 24 November. As Vienna is a playing venue only as of the Main Round, there is no set-up venue available in Vienna for the Officials Conference. Unlike usual the Officials' Conference will start on the day of arrival until 25 November. Officials travel to the assigned venues is scheduled for 26 November.

It has been agreed among the EHF, the organising committee (OC) of AUT and the OC of SUI that a second training hall will be made available for the teams. The draft version of the training schedule will be announced prior to the Heads of Delegations Conference and will be finalized afterwards taking the input of the participating teams into consideration.

Venue Set-up:

An early arena set-up is scheduled in Innsbruck, starting on 21/22 November, as there will be a test match between AUT and GER on 24 November 2024.
