## PART I | FHF BUSINESS

# 1. Welcome | Programme | Agenda

President Wiederer welcomed the Executive Committee (EXEC) to the 180<sup>th</sup> meeting on the eve of the 17<sup>th</sup> Ordinary EHF Congress, and the final meeting of the function period. In honour of the birthdays that occurred in the past months, President Wiederer presented EXEC Members Aksnes and Mallozzi with a gift. Moving into the agenda and following the tradition of the past four consecutive years, it was hoped that the EXEC would meet its responsibilities prior to going to the Congress the next day.

#### 2. EXEC Minutes 06/2025

With no question or comment, the minutes to the 179<sup>th</sup> meeting, as well as the circular decisions were approved.







# 3. Reports

# 3.1. Minutes / Report from the Finance Delegation

Henrik La Cour, Vice President Finances, opened the report by highlighting that three federations had not yet paid the outstanding balances. A financial plan was established with each federation and payment schedules until the end of the year were confirmed. In additional to the notes of the finance Delegation, the stable situation was underlined, and details were presented. The information on transfer income showed a 12% improvement compared to the previous year.

Further reports were provided on several topics: the 'Youth Club Trophy' and tax handling for the Final events, the tender for the auditing company, and the new travel and insurance provider for employees and representatives. A report on the credit line split into fixed and variable interest for EHF Services and Infrastructure GmbH, as well as the sales process of the previous EHF office, were also discussed.

**Learn Handball** | Additionally, a decision has been made to purchase shares of the App Learn Handball. The process to create the agreements, with legal support to safeguard the interests of the organisation, is currently underway. The agreement is expected to be finalized by the end of September/beginning of October.

**Sportradar** | Challenges in cooperation with Sportradar were noted, specifically issues with data feed stability. The EHF has exchanged legal letters with Sportradar and is seeking compensation for significant inefficiencies experienced during the 2024/25 season.

**EHF Master Plan & Motions |** Two motions regarding the EHF Master Plan were tabled:

- Prolongation of agreements for one year with Croatia, Georgia, Malta, and Scotland after the initial 3-year period expired.
- Proposal of new EHF Master Plan agreements with FIN, IRL, ARM, EST (staff member goals and activity plan by the end of the year), and KOS. These agreements will focus on youth sports and cooperation between schools and clubs.

Both motions were unanimously approved as written.

La Cour noted that out of a projected EUR 6 million investment announced in 2021, EUR 4.7 million were already contractually committed. Moreover, in the budgetary period of 2023/24, EUR 1.93 million were spent on the program. Adding to the information provided, President Wiederer highlighted the EHF strategy of investing in the development of Member Federations.







The level of investment continues to be a major factor in the progress of European national teams and respective activities.

# 3.2. Report from the Secretary General

From the written report submitted to the Executive Committee prior to the meeting, Secretary General, Martin Hausleitner highlighted specific points which were all supported by the individual topic reports.

Her Playground | the EXEC members were pointed to the article on the EHF homepage regarding the four female handball representatives who convened in Vienna to champion the new project 'Her Playground.' The project is a positive development, and it was suggested that it be promoted widely.

Infront A Strategy Committee meeting was also held, during which a new offer was presented by Infront to return the rights for club competitions. Three options had been previously presented to them: taking back the marketing rights for club competitions; taking back all rights, including the EUROs; or having the company cover any financial gap if they wanted to relinquish the club rights. Infront presented a new proposal in response and is currently analysing the situation. It was stated that no final decision would be made before the EHF Congress. Any agreement would first require coordination with the clubs, and the approval of the Executive Committee to formally sign adapted agreements by both parties.

**Digital Platforms |** Hausleitner highlighted the digital report and the latest figures across the EHF Media landscape.

Respect Your Talent (RYT) | the various summer activities were hailed a success. Webinars with ambassadors are held regularly, and more app content is being developed. Currently, over 1,500 players are registered via the RYT app. Preparations for the December RYT camp in Vienna have already started.

## 3.3. Report EHF Marketing GmbH

The minutes from the EHFM Advisory Board, combined with the Men's and Women's Club Board reports, were reviewed. The meeting itself was primarily an informational one, focusing on the current season and the successful conclusion of the previous one. The additional financial result has a positive financial impact on the EHF budget and resulted in additional payments to clubs. It was noted that within two to three weeks, a meeting of the EHFM Comptrollers Council would take place in Vienna to review the auditor's report and financial payments to the clubs can be done.







Wiederer gave a brief update on the status of the men's handball stakeholder groups as the Forum Club Handbal (FCH), European Handball League Association (EHL) and the European Handball Players' Union (EHPU) held their respective General Assemblies on the fringes of the FINAL4 in Cologne, as well as representation possibilities following the EHF Congress.

# 3.4. Report EHF Services & Infrastructure GmbH

CFO Bernhard Binder reported that the new office building's services and infrastructure are operating smoothly, and the finalisation of furniture orders is the main priority for September. While a final accounting statement has not yet been received from the project developer, a record of additional costs on the EHF side has been compiled for alignment with them. All service contracts for the technical infrastructure have been secured. Initial figures for external services, such as perimeter maintenance and window cleaning, have been received, which will allow for more concrete planning. A formal reporting process for energy consumption is also being established.

Regarding the financial situation, the final accounting for energy consumption has not yet been fulfilled, which affects payments and liquidity. An important update is the successful completion of the loan restructuring, which has determined the split between loan types and variable interest rate portions into three equal parts. These updates summarize the key developments in services, infrastructure, and financial matters since the last meeting in June.

#### 3.5. Further Reports

**Legal Report** | with the comprehensive legal report at hand, the two motions were presented by the MC Chairman and were dealt with immediately, and the overall report delivered by the President followed.

- Motion I | The first motion addresses the clarification of a "teaching unit" within the educational framework. To ensure consistency across all European Handball Federation (EHF) educational programs and member countries, a teaching unit will be standardized as 45 minutes. This will be applied uniformly, regardless of varying lengths in national educational systems, and will be incorporated into the regulations for official endorsement.
- Motion II | The second motion concerns the RINCK Convention manual, specifically regarding agreements between national federations and universities. A clear statement has been drafted to reflect that universities' degrees or postgraduate qualifications, once recognized by a national federation at a specific level (1, 2, or 3), will also be acknowledged by the EHF. This clarifies that such agreements are at the discretion of the national federations. A notable exception is the Master Coach Course, which still has specific, established requirements.

Both motions were unanimously approved as written.







Returning to the report, the purpose of the Initiator of Proceedings (IoP) was illuminated. The platform serves as the primary channel for receiving complaints, some of which pertain to shortcomings of Member Federations rather than case-specific outcomes. It is important that the IoPs maintain a balance role as they do function as an independent body that can make decisions on further procedures without being involved in the daily business of specific cases.

Continuing, the EXEC was presented with an updated list of current ECA Arbitrators from the Member Federations and other branches. All current arbitrators were contacted to confirm their willingness to continue in their roles. The EXEC took note of the information.

Furthermore, an issue regarding the approval of ECA regulations was identified. It is not clear which body is responsible for approving these regulations. This procedural imbalance is currently under analysis, as it raises governance concerns that need to be addressed for the EHF Statutes to be properly applied.

Sustainability Board (SB) | Member Bobinac in his function as the Chairman of the Sustainability Board stated that since the creation of the SB through its careful composition of external experts, the body has yielded significant results. With the primary objective being the recommendation of measures across all operational pillars of the EHF, the handball community has welcomed initiatives such as the Wheelchair Handball Development Plan the DEKRA partnership, and the collaboration with LIDL. In its advisory capacity, the SB focused on developing a comprehensive vision through detailed analysis. There is now a 'Sustainability' section on eurohandball.com, the SB has also delivered a survey to the Member Federations to gather insight on the various topics, the implementation of sustainability standards, as well as the latest initiative of 'Her Playground.' The introduction of a Sustainability Award further underscores the commitment to these values. The work of the board is viewed as an ongoing process and future topics for consideration have been identified.

Thanking outgoing Member Bobinac for his work within the SB, Wiederer suggested that a final report be compiled at the conclusion of the mandate to document progress and future recommendations. Member Lövgren emphasised the importance of sharing information with the Member Federations, who have shown interest in the initiatives, with the goal to facilitate others to replicate the successes achieved. Finally, it was proposed that a sustainability-focused article be created to publicize the group's accomplishments, serving as a public relations tool.

**Anti-Doping** | the Anti-Doping Unit of the EHF (EAU) submitted the report of activities, which also covered the entirety of the summer events. The EXEC took note of the information.







# 4. Technical Commissions 08/2025 - Minutes / Report

Before moving into the main reports, it was noted that the minutes of the Technical Delegation are at hand and emphasised that the bulk of the information was in the report.

## 4.1. Competitions Commission (CC)

CC Chairman Djurković referred to the minutes of the meeting that were distributed to the Member Federations as well as made available to the EXEC; he highlighted the following points:

Club Competitions | the current season started without any major issues, and all matches so far have been played according to schedule. During the first round of the European League Qualification, Djurković was also in Skopje to present the trophy and medals to the winners of the previous season, HC Alkaloid. Furthermore, EHF/EHFM club workshops for the Men's Champions League, the Women's Champions League and the Men's European League took place at the end of August.

**National Team Competitions** | the Women's EHF EURO 2026 Qualifier start in October. Special attention is to be paid to the matches of ISR due to the current political situation.

YAC Competitions | Looking to the 2026 summer events, the YAC EUROs will take place in SRB (M20) and ROU (M18). The M18 Qualification Tournaments will be played in November; following the completion of the QT, a call to host the Championships will be distributed.

Officiating | the season preparations were completed successfully at the end of August. The nominations for EHF EURO 2026 DNS are in progress and are expected to be completed after the Congress. For this event, online preparation sessions are also planned from October to December. The involvement of referee pairs from outside of Europe into the YAC competitions was considered by the Technical Refereeing Committee (TRC) and the Competitions Commission as good and beneficial; however, some organisational topics are to be clarified in case of future activities.

**Representation** | upon information from the Men's Forum Club Handball, Gael Pelletier from Nantes/FRA will continue in his current role of Men's Club Competitions in the CC. The representative for Women's Club Competitions is still pending. Looking ahead and following the election Congress, to the matter of the TRC, the newly configured EXEC must decide if there will be a TRC in the future.

#### **CC MOTIONS**

- Motion I | a technical issue regarding the number of the players that can be registered for a Younger Age Category competition
- Motion II | European Open (EO) Age Categories







- Motion III | EO to serve as a qualification to the European Youth Olympic Festival (EYOF) as well as the new Youth World Championship competitions.
- Motion IV | Audiovisual Rights of the EHF YAC Qualification Tournaments (excl. home market rights, betting rights)
- Motion V | Women's EHF EURO Cup Finals Venue requirements, adaptation of regulations for the 2026 event.

It is to be noted that each motion was presented, clarified, and discussed; questions that arose were answered. The five motions presented by CSO Glaser on behalf of the CC were approved as written.

## 4.2. Methods Commission (MC)

MC Chairman Sequeira supported the written report by highlighting the following.

Methods & Coaching | the analysis of the summer 2025 YAC events will be published by the end of October. Additionally, the EHF Injury Prevention Manual, which includes both theoretical and practical components, has been completed. Video clips demonstrating various exercises are currently being recorded, and the manual's release date has been adjusted to early October. The validation phase for the Players' Index has commenced in collaboration with the University of La Mancha, focusing on evaluating the usability of the EHF scouting data. In line with this, the EHF is in the process of contacting and evaluating a second developer.

**Education & Training |** To resume activities following the summer break, a series of webinars were planned for September. A specific session will take place on September 30, featuring elite goalkeepers Anna Kristensen and Gonzalo Pérez de Vargas. This online seminar is intended to serve as a preparatory event leading up to the upcoming Goalkeeper Summit.

Goalkeeper Summit | the conference will be held in Vienna at the beginning of October; the event is open to all interested participants and will form part of the Goalkeeper Specialisation Program. To date, there are 105 confirmed participants, and the summit will feature a distinguished list of speakers, including Mats Olsson (SWE), Matthias Andersson (SWE), Bobby White (ENG), and Amandine Leynaud (FRA).

**Coaching |** The curriculum for the EHF coach course has been enhanced to provide complementary education. The inaugural EHF-organised Level 3 course, implemented in collaboration with the Masterplan, was successfully concluded with its second in-person module, which took place in early September.

Youth, School & Non-competitive Sports | The curriculum for the EHF coach course has been enhanced to provide complementary education. The inaugural EHF-organized Level 3 course,







implemented in collaboration with the Masterplan, was successfully concluded with its second in-person module, which took place from September 5-7. The next edition of the EHF Open Master Coach PRO Licence course is scheduled to commence in the summer of 2026. The initial module will be held either during a Young Athletes Championship (YAC) EURO or at the Women's Champions League Final Four in Budapest, with the specific location yet to be determined. The second module is planned to coincide with the EHF Women's EURO in Poland, and the third module is set to be conducted during a YAC EURO in 2027.

#### 4.3. Beach Handball Commission

BC Chairwoman Horvath informed the EXEC on the most pertinent matters as reflected in the written report.

**ebt Finals** | The OC in Trapani, Italy has expressed its wish to continue as a long-term event partner by hosting further events and has submitted a letter of intent. Bidding for the 2026 event, planned for 18 – 21 June, is now open.

M/W16 Beach Handball EURO | despite the calendar clash with the IHF competition, the event took place in early July in Türkiye with 18 teams in both the men's and women's categories. The organisers were pleased with the participation and the high quality of play. On the fringes of EURO, a special project was undertaken to study the physical demands on players, particularly in high temperatures, in collaboration with a prominent researcher in Qatar, the hope is to continue this research.

**Beach Handball EHF EURO** | held under excellent conditions with a strong cooperation from the Handball Federation of Türkiye, the event was a resounding success with high spectator attendance across all three courts and increased digital engagement.

Other Events | The European University Sports Association (EUSA) event in Granada featured nine beach handball teams in both the men's and women's categories. The event was well organised; however, a need for greater EHF involvement in the preparation phase, especially for promoting the event and displaying the high quality of play from the university teams, was identified.

**Champions Cup (ChC)** I the event in Porto Santo is expected to be a success, with a full contingent of seeded teams demonstrating that the event remains appealing to clubs. The bidding phase for the 2026 and 2027 events is now open.

In a brief conversation that followed, the gap between the high interest from teams/clubs and the lower level of engagement from National Federations was illuminated. A key question was raised about how to transfer the enthusiasm of the teams/clubs to the NFs. Another point was







the growth potential, the need for continued promotion, and a place in the Olympic Games was also mentioned as essential.

**Officiating** | the number of officials remains stable. A new candidate program has been launched and is being refined, with eight pairs of officials from three tournaments collaborating with experts.

**Publications |** Two key periodicals have been released: one on the physical demands of the sport and another on psychological pressure during shootouts.

**Ticketing** | a brief discussion took place; while access to BH EURO events is currently free, the topic is being considered for the future as part of a strategic approach for the 2025–2029 business cycle.

# 5. Organisation of Events – Update

Supplementing the written report, comprising of information provided by the different departments, at hand, Secretary General Hausleitner reported as follows:

- YAC Events | A comprehensive report has been worked out on the summer competitions, highlighting increased visibility and the successful sale of TV rights for the W17 & W19 EURO events. A successful ticketing model, with ticket sales in Montenegro (MNE), has been a key discussion point.
- EHF EURO 2026 | preparations for the upcoming EUROs are underway, and ticketing for the EHF EURO 2026 DNS is being managed. While there are some challenges with one particular venue, this was anticipated from the outset, and the EHF continues to work in close cooperation with the OC. Promotion for the Women's EHF EURO 2026 has commenced, with additional promotional activities planned.
- EHF EURO 2028 | for the 2028 EURO events, the EHF is in close contact with the organisers and the event OC Spain/Portugal/Switzerland to finalize venues. Two options for the attractive opening match in Valencia have been proposed, with a quarter-final planned for one of the arenas that also hosts four basketball teams. However, concerns were raised about this arrangement, and after internal discussions, it was decided not to proceed due to financial viability and a lack of time to reorganize the finances for the environment, thus reverting to the basic agreement. A request from Sweden to change the venue for the Women's EHF EURO 2028 to Kristianstad was confirmed and approved.







- EHF EURO 2030/2032 | discussions are also ongoing regarding the new match schedule for the 2030/2032 team format, with a decision to be made by the new Executive Committee following the upcoming congress.
- Other Competitions | Regarding the IMGA and Masters Handball, its viability is decreasing, and a decision on EHF's continued involvement beyond 2027 will be made in 2026 after a thorough analysis.

#### **CC MOTION**

• Motion I | Introduction of the M60+ age category at the event in Portugal in 2026.

The motion was approved as written.

# 6. Other Topics

- IHF & IHF Council | No commentary was provided on the meeting, simply an acknowledgement of the information. The Continental Report for Europe was submitted ahead of schedule due to the upcoming EHF Congress. Support for emerging nations was highlighted, with a list of the specific nations from Europe included in a letter.
- 2026 Meetings | The schedule will be determined based on the competition calendar, with
  the draw for the March 26 competition already scheduled. Information on a new process
  for awarding MVP awards during matches was given to make the presentations timelier
  and more impactful.
- EXEC Nominations to EHF Events | nominations are being considered for those with the capacity to serve, and gratitude was expressed to the EXEC members who actively participated in recent events and especially the summer activities.

# PART II — CONGRESS PREPARATIONS

# 7. Programme / Agenda / Task distribution

No special report was given; the EXEC Members are referred to the available documents.

#### 8. Decisions on Congress matters (if necessary)

It was briefly noted that the Language Proficiency Evaluation Group held several meetings in July. It was stated that all candidates held an acceptable level and are therefore entitled to be part of the elections.







# 9. Open Questions

The Executive Committee briefly discussed a range of topics; the respective information is reproduced below:

- RUS/BLR Congress Participation | the status was reiterated; the National Federations of Russia and Belarus were invited but will not be represented at the 17<sup>th</sup> Ordinary EHF Congress. However, the three Russian electoral candidates are eligible and in legal compliance. Moreover, the situation regarding referees and delegates is to be reviewed by the Executive Committee of the 2025 2029 mandate.
  - ISR | the Executive Committee took note of the information that there might be some national governments that are forbidding their national teams to compete against national teams of Israel. It is to be noted that the EHF is aware of political difficulties now, as in the past; however, European handball has a long tradition in carrying out handball matches independent of political developments as long as the security of participants and the organisational capacity of Federations allow it.

# 10. Congress Follow-Up

Regarding the International Handball Federation (IHF), the situation surrounding the President's expected absence was clarified.

Member Bente Aksnes delivered a farewell message to the EXEC, as she would not be standing for re-election, as well as Member Blazquez by delivering personal gifts to the colleagues.

With no additional points of discussion, President Wiederer thanked the Executive Committee for their contribution during the meeting and over the course of the 2021 - 2025 mandate and closed the meeting.
