# 1. Welcome

Markus Glaser welcomed the newly elected Nations Committee Men/Women Members to the first meeting and expressed his congratulations to them for the new or respectively renewed functions/positions. Due to the organisational nature of the meeting, both committees held a joint meeting.

## 2. 2021 – 2025 Period – Perspectives

The EHF Nations Committee Men/Women and the NB/PHB/WHB structure as well as the integration of their respective members into various boards and the definition of the chairpersons into the EHF Executive Committee were discussed.





Morten Stig Christensen underlined the high importance of the strong position of the National Federations in the EHF structure and thus ensuring the right balance of the Federations business within the EHF. Therefore, the Nations Board must be very strong in discussions with the top Clubs and top Leagues during the PHB meetings. It is also very significant that the Federations exchange their information and best practices and ensure experienced representation for the future.

Glaser informed that in the area of National Team Competitions Mario Kovacic will succeed Peter Sichelschmidt, who will retire in September 2021.

### 3. Information on further timetable

Further Glaser provided brief information in respect of the EHF Meeting Calendar 2021 and more specifically the scheduled meetings of the boards (NCM/NCW/NB; PHB/WHB).

### 4. Decisions / Nominations – further procedure

Christensen requested the flow/timeline of the meetings of the committees and boards as well as the proposed representation of the committee members in the respective boards (NB/PHB/WHB). The information flow is very important, the EHF will provide this information and the preparatory documents prior to the next Nations Committee Men/ Women and Nations Board meeting, which are scheduled to take place in Vienna on 26 May 2021. No parallel meetings (EHLB/PHB/WHB) will take place in May 2021. The EXEC will confirm or nominate during their meeting in Cologne in June 2021 all proposed representatives in the various boards (NB/PHB/WHB, also MCB and WCB, so that the EHF commissions and board structure will be completed in June 2021.

#### 5. Organisational matters

The Members provided their personal data for to the EHF data base and to further administration.

#### 6. Miscellaneous

Glaser thanked to the NCM/NCW members for the participation wishing them good work within the EHF structure.
